

2008 The final draft of the SANS 10400-T:2008 came to our attention. It was with dissatisfaction and astonishment that we noticed that TASA's objections were not only ignored but the specification had been changed to the utmost detriment of the Thatching Industry if it was promulgated in that form. Members and role players in the Industry were informed of TASA's objections and suggestions to the Technical Committee of the SABS. Negotiations with the SABS continued.

## 2009 The First National Thatched Roof Competition held for Architects and Architecture students were so successful that the competition was repeated in 2010



The University of Pretoria's second year Architect students accepted the challenge. Three entries were received to which seven students worked. Each participant also received a certificate of participation.

2012 During October, a delegation of eight TASA members attended the International Thatching Society's Congress in the Netherlands and Germany, during which it was decided to hold the 2014 Congress in South Africa.

## 2013 The TASA Constitution and Source documents had been revised. U- and R-Values – Energy Efficiency in Buildings

All thatched roofs must comply with the SANS 10400-XA and SANS 204 Standard requirements. The correct U-values must be available to the Industry. Air permeable roofs like thatched roofs, were not provided for in the above Act. Discussions were successfully held with the various relevant authorities such as The National Regulator for Compulsory Specifications (NRCS), various Committees of the SABS, representatives of the Thermal Test Laboratory, etc.

## 2014 TASA HOSTED THE ITS CONGRESS IN THE CAPE WHICH WAS THE HIGHLIGHT OF THAT YEAR


## 2016 The launch of the TASA's "A Guide to Thatch Construction in South Africa"





